Castlerock Kennels reserves the right to name all puppies with the prefix "Castlerock.", failure to do so will make this entire contract null and void.

No guarantee is made at time of sale regarding show, or breeding prospects of sold dog.

This dog is guaranteed to be in good health, to the best of my knowledge at the time of this sale, and has had initial inoculations against distemper, hepatitis, para/parvo virus and received worming. The buyer has **(3) three days** from day of purchase in which to have the dog checked by a licensed veterinarian, and is urged to do so. If the veterinarian finds the dog to be seriously ill, the cause of which is clearly hereditary in nature (this does not include presence of parasites, protozoa or kennel cough), return the dog along with the AKC Registration papers. Another pup of similar breeding will be given in exchange, or money returned if no other pups are available at that time, provided a letter from the examining veterinarian is offered as proof of severe hereditary illness. It is agreed and understood that any exchange must be made within the three-day guarantee period. The seller assumes no responsibility for this dog after leaving premises for medical expense, mortality, landlord's disapproval, allergic reaction to dog, disagreement with family, behavioral/training difficulties, mistreatment of dog, accidental poisoning or trauma to dog, or for any other reason.

This dog is also guaranteed to **one year** of age against severe, life-threatening congenital heart, liver, kidney, or thyroid defects, cancer, seizure disorder. Should any of these defects occur, which are clearly hereditary in nature and severely affect the dog's quality of life, return the AKC Registration papers and a letter from **two** licensed veterinarians confirming the defect(s) and a spay/neuter verification from your vet. All required paperwork must be received by Castlerock Kennels within 6 months of initial diagnosis or this contract is null and void. A puppy will then be offered as a replacement of equal value (breeder's choice) when next litter of comparative value is available. This guarantee does not cover what is to be considered prevalent to the Bulldog breed, any eye disorders, cherry eye, entropion, hip dysplasia, skin conditions and skin allergies, elongated soft palate. If replacement pup is given, it is the sole responsibility of the buyer for the return shipping to the breeder and the shipping costs for the replacement pup. No discounts will be given.

This is limited to a one-time replacement and no further guarantees are made. It is agreed and understood no money refund or discounts will be given.

In the event of litigation regarding this dog or contract; it is agreed all litigation will occur in the county of Franklin, North Carolina.

It is further understood and agreed that no warranty or representation has been made with respect to sold dog, except as set forth in writing in this agreement.
